



HOW TO SUPPORT  
L'ABBAYE DE LONGUES  
THROUGH THE KING BAUDOUIN FOUNDATION



**The King Baudouin Foundation** is a public benefit foundation approved by law. The Foundation was set up in 1976 on the occasion of the 25th anniversary of King Baudouin's reign. The King Baudouin Foundation's mission is to contribute to a better society.

Donations of 40 euros or more made via the King Baudouin Foundation give rise to a tax reduction of the amount actually paid and stated on the certificate.

### *Enabling Donations*

Along with enabling donations from Belgian donors, the King Baudouin Foundation is now registered in a number of European countries, thus allowing direct (cross-border) donations on our account in Belgium with all the tax advantages directly in those countries.

Donors in Canada will be able to benefit as well from the tax advantages, by donating to KBFCanada.

Furthermore, the Transnational Giving Europe Network will enable donors from 15 additional countries around Europe to make tax effective gifts.

This document aims to help the Founders of Funds under the umbrella of the King Baudouin Foundation to provide international donors with practical information needed to make tax deductible donations.

We divided the countries in four categories. Namely:

- 3) Transnational Giving Europe
- 4) Other countries

Transnational Giving Europe (TGE) is a partnership of leading European foundations and associations facilitating tax-efficient cross-border giving within Europe. The TGE network enables donors, both corporations and individuals, resident in one of the participating countries, to financially support non-profit organizations in other member countries, while



benefiting directly from the tax advantages provided for in the legislation of their country of residence.

Funds having donors in the following countries: Bulgaria, Croatia, Estonia, Germany, Hungary, Italy, Poland, Romania, Slovakia, Slovenia, Spain, Switzerland and UK can use the network to allow tax deductible donations from these countries.
